Presidents Report July 2021-June 2020

Dynamic activity continues within The Aurum Project, (AP) now in its 16th year as Australia's only homeopathic charity, recognised by the Australian Charities and Not-for-profit Commission (ACNC).

The emphasis in the past year has been to establish international connections, displaying the AP's activities, and developing a framework for future research:

1. Bronze Level Sponsor, AT THE Homeopathic Research Institute (HRI) Conference June 2022 The AP established a wider awareness of its activities at this conference, by displaying its Logo and conducting a virtual "Breakout Room" during the conference. It encouraged new members with discounted entry into the breakout room for AP Members. Attendees were encouraged to go to the The AP website and subscribe to the online newsletter.

2. Bronze Level Sponsor New Zealand Council of Homeopaths (NZCH) online Conference April 2022 Utilising another opportunity to connect with members and grow membership.

Connecting Homeopaths hosted a breakout room, for attendees to share ideas, concerns, successes, and discuss research plans.

Most of the AP Management Committee and members attended.

3. The Book Barn

This service to the professional and general public is proving to meet the needs of those interested in learning more about homeopathy, with the bookstore growing further this year, significantly boosting the AP's fundraising capacity as a charity. This has been greatly strengthened by a large donation of homeopathic books from the Nature Care College library.

The AP's Book Barn has become the main source of homeopathic books in Australia and now distributes books by several leading international authors. It is now the major source of income for the AP.

4. Research Pods

Several research groups continue their activity in these areas:

- Recurrent Urinary Tract Infections
- Molluscum contagiosum
- Teal management theory
- Water project

With a further pod planned on respiratory diseases.

Future areas of research are helping to define the profession itself:

- A review of Australian Homeopathic Research since 1990
- A Workforce Survey of Homeopathy in Australia
- An Australian Homeopathic Association /AP Collaboration on community building.

Details of all projects are on the AP website.

With enough resources, the AP seems poised to take on larger research projects in the future. Those responsible for driving this development, namely Linlee Jordan and Dr Celeste Salter, are to be congratulated on their devotion to the development of the AP.


Our Members



According to Facebook, these were our most "shared" posts for financial year 2021/22










Research Outcomes to June 2022

During the last financial year (July 2021-June 2022), our research activities covered six areas:

- First National Survey of Homeopaths in Australia
- Research Priorities for Homeopathy in Australia 2018 2024
- Research Pods Activity
- New Pod Activity
- Cluster Sessions
- Ethics Training Module
- 1. A series of Melting Pots were initiated in August 2021 through to Feb 2022, using the reflections and review of The First National Survey of Homeopaths research project outcomes as the starting point. 5 sessions were held where Aurum Project members and AHA members were invited to attend the five online sessions. The summaries of the discussions were posted in the AP members area and in the AHA professional forum. Three focus areas arose:

Workforce Survey - a Pod has formed to initiate and conduct a yearly workforce survey of Australian practitioners. This activity is in partnership with Australian Register of Homeopaths (ARoH) Homeopath Unique Practice - initial discussions between 5 interested members began, and continued with 3 members throughout the year.

Patient and Communication - discussion on this topic with 4 members continued throughout the year.

2. The Research Priorities Working Group continued to meet quarterly throughout the year, tracking activity on the building blocks defined in 2018. The meetings are well attended, and include representatives of different organisations, education and suppliers interested in homeopathy research in Australia. The Aurum Projects hosts these meetings and facilitates the meetings.

3. Research Pod Activity

Throughout the year research activity continued in these Pods

- UTI Research Pod The research Pod had two members retire, Sarah Penrose and Andrew Samson.
- Molluscum Contagiosum Pod extensive literature review and analysis of the history of Molluscum had occurred. The Pod published a blog.
- Systematic Review volunteer support assisted the curating of research papers, and the Pod continued to rate the papers.
- Teal Vision Pod a paper was being finalised for submission to Simlia on the origins of the Pod concept and the theories supporting the use of the concept for The Aurum Project. Deeper clarity on the importance of the relationship between Pod members and the role Connecting Homeopaths has in bringing AP members together across the country was achieved.

4. New Pod Activity

In February 2022, discussions with Dr Charu Grover on the topic of Respiratory disease began. The topic comes out of Dr Grovers experience in Asthma research, and issues of patient education and compliance with asthma protocols. There are significant issues around CAM support and treatment in this area, including education of practitioners and patients, that this project topic could address. In June 2022, invitations were made to AP members to join discussions with a view to forming a research Pod. The first session was due in July 2022.

The Workforce Survey Pod formed to initiate and conduct a yearly workforce survey of Australian practitioners. This activity is in partnership with Australian Register of Homeopaths (ARoH). An IP agreement has been drafted between AP and ARoH to guide the project.

5. Cluster Sessions

In 2022, the concept of Pods sharing their research activity with each other was initiated with an online event called a Cluster Session (a collection of Pods is called a Cluster). These bi - monthly sessions are held for Pod members to update each other on their progress, research activity, interesting findings, and potential blockages to progress. It is an opportunity for each Pod to share, speak, and present their research activity. All AP members are invited to join in these sessions for free and be part of the discussions after the initial updates. Other non AP members are also invited to attend for a small fee. The sessions are recorded to assist the Pods in capturing any ideas that are generated in discussion.

6. Ethics Training Module

During this year we made contact with Sitback and spent some time scoping a game of ethical conundrums for AP members to participate. The bulk of this activity occurred during lockdown, and we may revisit this in 2023 finalise the game, and offer it as an event to members. It would bring valuable insight to our members who play it, both personally and professionally. We also created an AP Ethics Training Module to assist all Pod members in understanding the ethical considerations of their project. This module has ARoH accredited CPD for those who complete it.

To Summarise

Overall, this has been a very productive year for our research activity. This success has been despite the issues confronted personally by members and collectively by AP with lockdown and covid. We have seen the Pods settle into working self determined structures that are suitable for the Pod members, and their project plans are being created. The two new Pods currently forming are looking promising. We also know that each project will have expenses that AP and the Pods will need to resolve, for example the costs associated with Human Research Ethics Committee applications. We expect in the next year to tackle these financial issues and find a range of solutions, as some costs will be incurred even though our members' effort is volunteered.
